RELEASE AND INDEMNITY—PLEASE READ CAREFULLY

Definition of Released Parties

For the purposes of this waiver, the term “Released Parties” refers collectively to:

- **Running Room Canada Inc., Running Room Athletic Club, Running Room (U.S.A.) Inc.,** and any associated or related entities;
- Their directors, officers, employees, agents, representatives, volunteers, and organizers;
- Any **sponsors, third-party contractors, vendors, or service providers** engaged by the Event Organizers to assist with the planning, management, promotion, or execution of the Event.

Acknowledgement of Risk and Medical Responsibility

I acknowledge that participating in physical fitness events, including this event and all related activities (the “**Event**”), is a potentially hazardous activity. I, on behalf of myself and any minors or third parties for whom I am registering (collectively, the “**Participants**”), agree not to participate unless medically able and properly prepared. I understand that the **Participants** are solely responsible for their own medical well-being and undertake to have medication and medical information available in case of a medical event requiring attention. Participation should not occur without a physician’s approval. I consent to assessment and treatment by medical personnel during the Event, including first aid, stabilization, and transport to medical facilities if required.

Assumption of Risk and Participant Responsibilities

The **Event** includes, but is not limited to, all activities, events, or services in any way provided, organized, sponsored, or authorized by the **Event Organizers**, including any **sponsors, third-party contractors, or service providers**. On behalf of the **Participants**, I agree that:

- We will abide by any decision of an **Event** official concerning our ability to safely participate;
- We assume all risks associated with the **Event**, including but not limited to falls, contact with other persons or objects, the effects of weather, traffic, course conditions, terrain variations, physical exertion, dehydration, equipment failure, and negligence on the part of the Released Parties, including failure to take reasonable steps to safeguard or warn of such risks; and
- We consent to and accept responsibility for emergency treatment in the event of injury or illness.

Registration Transfers and Refunds

I acknowledge that registration fees are non-refundable and non-transferable, **except where transfer functionality is explicitly enabled by the Event Organizers through the official registration platform or other approved channels**. I understand that unauthorized transfers, including bib exchanges outside of permitted systems, may result in disqualification from the Event. I further acknowledge that I will not be entitled to a refund if the Event is cancelled, rescheduled, or modified due to circumstances beyond the control of the Event Organizers. These circumstances may include, but are not limited to, **severe weather, natural disasters, public health emergencies, acts of government or civil authority, safety concerns, or other force majeure events**.

Release of Liability

As a condition of entering this **Event**, I, on behalf of the **Participants**, hereby waive and release the **Released Parties** from present and future claims and all liabilities of any kind, known or unknown, arising out of participation in the **Event** or related activities, even if such claims arise out of negligence or fault on the part of the **Released Parties**, including any duty of care owed under applicable provincial or federal law, whether statutory or common law.

Indemnification

I agree to hold harmless and indemnify the **Released Parties** from any and all liability for property damage or personal injury to any third party resulting from participation in the **Event**.

Use of Personal Information

I grant permission to the **Event Organizers** to use, or authorize others to use, the **Participants’** personal information, including but not limited to photographs, images, likenesses, voices, race results, and documentation of participation in the Event or related activities, without remuneration. I acknowledge that all photographs, videos, and recordings taken during the Event are the property of the Event Organizers and may be used globally, in perpetuity, without compensation, for promotional, commercial, or informational purposes. I waive any right to inspect or approve the use of such materials. Translations of this waiver are available upon request to ensure full understanding.

Representation and Authority

I represent and warrant that:

- I am over eighteen (18) years of age, and if registering a minor, I am the parent or legal guardian of such minor. I confirm that I have the legal authority to consent on their behalf;
- If registering third parties, I have been duly authorized to act on their behalf;
- The terms of this registration and waiver apply equally to me and to all **Participants** for whom I am acting. Participation by a third party confirms that I was acting as their agent. I accept full responsibility for ensuring that all Participants for whom I am registering have read and understood this waiver.

Retention of Waiver

I acknowledge that this waiver will be retained by the **Event Organizers** for a minimum period of five (5) years and may be provided to applicable authorities upon request.

Jurisdiction

This Waiver shall be governed by and construed in accordance with the laws of the Province of Alberta. Any disputes arising under this Waiver shall be subject to the exclusive jurisdiction of the courts of Alberta. This Waiver does not waive any rights that cannot be legally waived under Alberta law and is intended to comply with applicable consumer protection and liability legislation.

Severability

If any provision of this waiver is found to be invalid or unenforceable, the remaining provisions shall remain in full force and effect.

Digital Acceptance

By signing this form in person or submitting it electronically, I acknowledge that I have read, understood, and agree to the terms of this Waiver. I understand that my signature or electronic submission constitutes a legally binding acceptance of these terms.

Participant Understanding

I confirm that I have read and understood this Waiver in its entirety, and that I have had the opportunity to ask questions, seek clarification, or request a translation before agreeing. I acknowledge that I have had sufficient time to review this Waiver prior to my child's participation and that I understand the risks involved.

Agreement

I have read and understood this waiver and agree to its terms on behalf of myself and all **Participants** for whom I am registering. This waiver shall be binding upon my heirs, next of kin, executors, administrators, assigns, and legal representatives in the event of my death or incapacity.
